WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the Hastings Lions Club's Apple Festival (the "Event") from September 26 through September 27th, 2026, I hereby release, waive, discharge and covenant not to sue the Hastings Lions Club, Lions International, the Town of Hastings, County of Oswego, Reymore Chevrolet, Presenting Sponsor, 60 US RT 11, LLC, MDL Brewerton, LLC or any property owner that may allow us to use their premises or equipment, or any of the officers, members, servants, agents and employees (hereinafter referred to "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees or otherwise, while participating in the Event, or while in, on, or upon the premises where the Event is being conducted, while in transit to or from the premises, or in any place or places connected with the Event. If I am signing this on behalf of an organization, I attest that I have authority to do so, and agree that my signature covers all persons involved with the festival on our behalf.
2. I am fully aware risks and hazards connected with being on the premises and participating in the Event, and I am fully aware that there may be risks and hazards connected with being on the premises and participating in the Event, and I hereby elect to voluntarily participate in the Event, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous, or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the Event, whether caused by the negligence of releasees or otherwise.
3. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs, including reasonable attorney's fees and expenses, they may incur due to my participation in the Event, whether cause by the negligence of any or all of the releasees, or otherwise.
4. It is my express intent that the Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue the above named releasees.

In signing this release, I acknowledge and represent that:

- A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed.
- B. No oral representation, statements, or inducements, apart from the foregoing written agreement, have been made.
- C. I am at least eighteen (18) years of age and fully competent, and
- D. I execute the Release for full, adequate and complete consideration fully intending to be bound by same.
